- 3.2. Review of connected load, sanctioned load/contract demand.
- 3.3. Review of the complete electrical distribution system.
- 3.4. Verification of statutory compliance with respect to Indian Electricity Rules 1956/CEA 2010 Regulations/Acts.
- 3.5. Review of quality of electrical safety and protective systems like Main switches, MCCBs, MCBs, ELCBs/RCBs, Isolators etc.
- 3.6. Physical inspection to identify electrical hazards (shock, electrical protection system, fire, explosion, controls, installation, maintenance, LOTO etc.) and to suggest electrical safety solutions.
- 3.7. Review of static electricity hazards in the Electrical System/Installation operations as per IS 7689.
- 3.8. Review of Electrical System/Installation lightning protection system (need, adequacy, installation, and maintenance) as per IS 62305.
- 3.9. Review of electrical accidents and near-misses in the Electrical System/Installation to identify the root causes.
- 3.10. Review of electrical systems & procedures (work permits, interlocks, lockout tags, etc.).
