1. BACKGROUND

1.1. About ACCF

- a) Assam Cancer Care Foundation (ACCF) is the collaboration of Tata Trusts and Government of Assam ("GoA") in view to optimally plan, design and implement distributed cancer care facilities across the States of Assam through a need-based approach. ACCF is mandated to create patient-centric cancer hospitals across the state to deliver standardized, highquality and affordable care closer to patients' homes and thereby to mitigate the financial burden.
- b) In addition to Cancer Care, ACCF is embarked on preventive strategies to reduce the incidence of cancer in the State.
- c) ACCF is a Company registered under Section 8 of the Companies Act 2013 having its Registered Office in Guwahati, Assam.

1.2 About this RFP.

- a) ACCF, through this RFP process, intend to empanel/select eligible party(s) (i.e., service providers), as one time measure to facilitate provisioning of specified services in a short notice to meet requirements for environment clearances for its sites in different locations in Assam. The Agency(ies) having a strong base in Assam shall be preferred.
- b) This Request for Proposal (RFP) is invited from eligible parties (i.e., service) willing to be prequalified for the specified categories of service(s) to ACCF in Guwahati or its offices in various districts in the State of Assam.
- c) All disputes will be subject to courts in Guwahati, Assam only.

- 2.2.3. ACCF will evaluate RFP applications based on the evaluation criteria as set out in this RFP.

2.3. Conflict of Interest

- 2.3.1 The situation of "conflict of interest" between two or more applicants or between the procurement official(s) and the applicant may arise by virtue of their relationship and position.
- 2.3.2 A participant shall not have conflict of interest with other Applicants. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's interests. The Applicant found to have a conflict of interest shall be disqualified. An Applicant may be considered to have a conflict of interest with one or more parties in this RFP process, if:
 - a) they have controlling partner (s) in common; or
 - they receive or have received any direct or indirect subsidy/financial stake from any of them; or
 - c) they have the same legal representative/agent for purposes of this RFP; or
 - d) they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the RFP of another Applicant; or
 - e) Applicant submitting more than one RFP in this RFP process (Clarity: Applicant can participate for more than one category but cannot submit two or more RFPs separately for same category). Participation by an Applicant in more than one RFP will result in the disqualification of all RFPs in which the parties are involved. However, this does not limit

the inclusion of the components/sub-assembly/assemblies from one applicant/manufacturer in more than one RFP.

2.4. RFP Processing Fee & Bid Security

- 2.4.1 The RFP Processing Fee and EMD shall be paid by the bidder in the following manner:
- 2.4.1.1 The Tender Processing Fee of Rs 500/- shall be ffurnished by the bidder either in the shape of Demand Draft (DD) from any scheduled bank in India drawn on "Assam Cancer Care Foundation, Guwahati" or vide online transfer/NEFT which should be submitted along with the technical bid as proof of payment. Non-payment of the processing fee shall render the bid liable for rejection.
- 2.4.1.2 The bidder can furnish the EMD (i.e., Bid Security) amount in either of the form given below:
 - a) Demand Draft or Fixed Deposit Receipt (FDR) duly lien marked in favour of Assam Cancer Care Foundation or
 - b) Irrevocable Bank Guarantee (BG) issued in favour of Assam Cancer Care Foundation by any scheduled bank in India as per the format given in Annexure-V.
 - c) Online payment (NEFT/RTGS/IMPS)
- 2.4.1.3 The bidder has to submit (online) the scan copy (in PDF format) of the DD or BG drawn in favour of ACCF towards Processing fee and EMD along with other documents as required for technical bid on or before the due date and time of submission of technical bid.
- 2.6.2.5 However, the bidder has to submit the original instrument of the Tender processing Fee & EMD(s) in a sealed envelope along with other **key documents** as mentioned elsewhere in this document to be submitted to the Tender Inviting Entity on or before the due date of submission of "**Key Documents**" as mentioned in the NIT.
- 2.6.2.6 The bidder is solely responsible to ensure that originals of these key documents reach in the office address of ACCF within due date as mentioned in the NIT. The bidder may choose to submit the original key documents either by hand or vide courier or postal service in the office address of the ACCF. However, the Tender Inviting Entity (i.e., ACCF) shall no way be responsible for any delay caused by the courier or postal agency. The sealed envelope containing the original key documents including original instruments (GB/DD/FDR) towards Tender Processing Fee & EMD should be clearly super scribed as "Key Documents, RFP Reference No." along with name and address of the bidder.
- 2.6.2.7 The bank details of ACCF are given below for *online payment* of Processing Fee and EMD. The bidder has to upload the document in support of the online payment of the Processing Fee and EMD along with the technical bid.

2.6.3 Earnest Money Deposit (EMD):

- 2.6.3.1 The amount of EMD to be submitted for the item(s) tendered by the bidder is mentioned at **Section III** and Non- submission of EMD as mentioned in **Section III** shall be one of the primary reasons for rejection of the offer in the first round.
- 2.6.3.2 Total EMD amount shall depend on the item(s) the bidder chooses to bid. There is only single EMD (of Rs. 25 Thousand) irrespective of no. of sites quoted.
- 2.6.3.3 EMD of unsuccessful bidders will be discharged/ returned within 30 days of finalization of tender.
- 2.6.3.4 The successful bidder's EMD will be discharged upon successful completion of the work. EMD shall be treated as Performance Security.
- 2.6.3.5 No interest will be paid for the EMD submitted.
- 2.6.3.6 The EMD shall be valid for a period of 12 months from the date of submission of bid which may be extended further on mutual consent.
- 2.6.3.7 The EMD will be forfeited, if a bidder.
 - a) Misrepresents facts or submit fabricated / forged / tampered /altered / manipulated.
 - b) Withdraws bid after opening of technical bid.
 - c) A successful bidder, fails to sign the contract after issuance of Letter of Intent/Award

- b) Bidder should be Accredited with EIA Consultant Organization. Bidder need to produce empanelment Certificate issued by National Accreditation Board for Education and Training(NABET).
- c) The applicant should be registered sole entity and having appropriate authorisation or licensing to provide the selected services in India. Joint venture or Consortium are not allowed to participate.
- d) It may be noted that applicant is required to furnish a certificate (with UIDN) for average annual turnover from a registered Chartered Account. However, ACCF reserves the right to ask Audited (if applicable) Balance Sheets for the last three financial years, if required at any stage.
- e) The Applicant should not have abandoned any work in the last five years; should not be blacklisted; should not have had any of its contracts terminated for failure to perform; should not have suffered from bankruptcy / insolvency or been a subject of any legal proceedings for these matters; should not have been involved in frequent litigations in the last five years.
