Roles and Responsibilities:

- 1. To provide comprehensive medical care and pain management that is aimed at enhancing comfort and quality of life of palliative care patients.
- 2. To liaison with the primary physician/department referring the patient for palliative care in designing the care plan for each patient and implement the multidisciplinary care approach towards patient care.
- 3. To coordinate with other specialists/departments for their specialty service and inputs for palliative care patients whenever necessary.
- 4. To coordinate out-patient department, indoor ward & home-based palliative care activities in coordination with the parent department of the institute (Medical College/District Hospital of station).
- 5. To provide support and education to the patient and family, including teaching them about the expected course of disease, preventive care, medication use, and self-management and crisis intervention in the home setup.
- 6. To attend in house training programs as and when planned by the higher authorities for enhancing competency and capacity.
- 7. To liaison with healthcare providers and institutions as well as pertinent government/ non-government bodies with whom ACCF has professional relationships for referrals and for raising awareness of palliative care.
- 8. To establish links with new stakeholders to increase enrolment of patients in close coordination with the Medical Director.
- 9. Impart generalist palliative care training of nurses, social worker, psychologist and other complementary care providers which form the core palliative care team of the Centre.
- 10. Discuss views in the weekly meetings to prepare various actions plans required to implement, monitor and evaluate palliative care outreach programs of ACCF.
- 11. To actively participate both as a trainee and resource person in Continued Medical Education, Seminars and other training programs.
- 12. To prepare financials and budget related to the centre's requirement and ensure its timely submission for smooth functioning of the centre.

- To be Responsible for all regulatory compliance on Radiation Safety as per AERB guidelines.
- To test, repair and calibrate radiation measurement instruments and other instruments.
- The RSO shall ensure that radiation safety activities are being performed in accordance with approved procedures and regulatory requirements in the daily operation of the licensee's program.

- To be responsible for ensuring that the licensee's radiation safety program is implemented in accordance with approved procedures must have adequate training and experience.
- To conduct all mandatory routine reporting as well as reporting and emergency response to any events.
- To ensure that the provisions of the Atomic Energy (Radiation Protection) Rules,2004 or modified thereafter, are implemented.
- To establish and maintain an effective radiation protection programme to ensure safety of workers, patients and public.
- Instruct all workers on relevant safety measures.
- To assist the licensee in developing suitable emergency plans to deal with accidents and ensuring appropriate emergency preparedness.
- To provide adequate training in radiation protection and safety methodologies to all workers.
- To implement all radiation surveillance measures.
- To conduct periodic radiation protection surveys to verify compliance with the regulatory requirements.
- To ensure safety of the staff in the Unit with regards to radiation exposure that include wearing of protective shield ,TLD badges along with quarterly check and replacement of the badge if needed.
- To carry out personnel monitoring and maintain records thereof.
- To ensure periodic calibration of radiation measuring and associated instruments.
- To submit periodic reports to the competent authority giving details such as safety status of the installation and inventory of sources.
- To ensure timely renewal of Licenses of the Organization with regard to the use of Radiation therapy.
